## **Pre-Delivery Activity Report**

### Purpose of this document

In accordance with § 1073 of the CRM Functioning Rules as published on 13 September 2024<sup>1</sup>, ELIA has the obligation to publish on its website, by 31 March 2025 latest, a pre-delivery activity report for every Delivery Period covered by the pre-delivery controls during the past year.

The Functioning Rules of the CRM outline two moments of control designed " to ensure that a CMU's Total Contracted Capacity becomes effectively available (if the Total Contracted Capacity is associated to an Additional or a Virtual CMU) or remains effectively available (if the Total Contracted Capacity is associated to an Existing CMU) as of the Transaction Period."

This document provides the outcomes obtained during the first control phase (referred to as  $t_{control\,1}$ ) for CMUs that were contracted for the Delivery Period 2026-2027. As no Y-4 auction took place in 2022, no  $t_{control\,1}$  moment took place in 2024.

## Overview of the $t_{control \, 1}$ results for the Delivery Period 2026-2027

Due to the absence of an auction in 2022, no capacity was selected for the 2026-2027 delivery period. Consequently, no  $t_{control\ 1}$ took place on August 31, 2024. This outcome is detailed in the Y-4 Auction Report for 2026-2027 published by Elia Transmission Belgium SA, which confirms that the total selected capacity for the auction was 0 MW, resulting in no Capacity Market Units (CMUs) being selected.
